1. Policy Statement

7.3.1.6 Tuition for Georgia's "Dual Enrollment" Program

Tuition for high school students participating in Georgia's "Dual Enrollment" program shall be charged on a per-credit-hour basis at Gordon State College. Gordon State College will accept the amount reimbursed by the Georgia Student Finance Authority (GSFA) for Dual Enrollment tuition charges as full payment. Any tuition amount for MOWR Dual Enrollment not covered by the GSFA reimbursement shall be waived.

2. Reason for Policy

To mirror USG BOR Policy in regards to charges of Dual Enrollment tuition and fees and ensure that students are being charged correctly.
