- A current ID issued by the State of Georgia **for a period longer than 2 years.**
- A current U.S. military ID (*May be provided for service member only. Not acceptable for a military dependent.*)
- A current U.S. Passport
- A U.S. Certificate of Citizenship (USCIS form N-560 or N-561)
- A U.S. Certificate of Naturalization (USCIS form N-550 or N-570)
- A current, valid Permanent Resident Card (USCIS form I-151 or I-551)
- A Certified U.S. Birth Certificate showing that you were born in the U.S. or a U.S. territory. *A photocopy is not acceptable.*
- A U.S. Certificate of Birth Abroad issued by the Department of State (DS-1350 or a Consular Report of Birth Abroad (FS-240)).

By submitting this application I consent to Gordon State College's global consent to do business electronically where the primary method of communication is the student's Gordon Email account. This consent constitutes billing for charges, receipt of 1098-T tax form unless written request for paper form per instructions via Business Office webpage, late payment notices, collections, and other student business related notices to be electronic.
